Dates

Point in Time count will be the evening of January 27, 2022

Unsheltered Point in Time count will be January 28th, 29th, and 30th

These dates will survey where people were the night of January 27th.

General

Will be consistent with how it was conducted last year

Social media posts for partner agencies to share to reach more individuals

Some technological changes so the survey so mobile and tablet friendly

Will be working out of Iron Gate during the PIT count

Quick Trip and others are working on putting kits together to hand out to individuals surveyed Surveys will be conducted outside of Tulsa City, within Tulsa County

Volunteers

Working with community leaders to get them involved

10 teams will go out on Friday, 7 teams on Saturday and Sunday

YST will have volunteers out Friday morning, in the afternoon they will conduct counts from their location to facilitate drop ins

Walk through of survey

New form from last year

Upgrade – user friendly for phones and tablets

Survey starts with a brief introduction from the volunteer – explaining to the individual who they are and the purpose of the survey

The first question is regarding confidentiality and asking the individual if they would like to complete the survey

Survey includes geotagging – automatically defaults to the volunteer's location with the client Shows areas of concentration

Can be moved if it is not at the exact location

Questions have branches – so several questions have dropdown branches

Questions are the same as previous years and in accordance with HUD

Sections of the survey

Household

Client's name and DOB – also questions regarding spouse/partner and children Additional Demographics

Race (primary race only), gender (multi select option), military service History of Homelessness

Area, length of homelessness, number of times the client has experienced homelessness in the last 3 years

Barriers to Housing

incarceration, mental health issues, physical disabilities, etc.

Causes and Gaps

Causes of homelessness (multi select)

Services the client and household need (multi select)

Reports will be run each day

Thursday – end of the day

Friday – around noon and end of the day

Saturday – around noon and end of the day

Sunday – around noon and end of the day

Final report after Sunday

Running reports against HMIS to see which clients we are already working with
