  - A second form will be provided if the client does not agree with the decision to terminate participation and request an appeal. The client may provide additional documentation, adding if the case manager will be part of this appeal in any way.

### A WAY HOME FOR TULSA

Request for CoC Leadership Council Committee Agenda Item

#### **1.** Brief Description of Proposed Item:

At present, the Tulsa housing opportunities for persons experiencing homelessness include additional eligibility factors prior to referral matches. In addition to the HUD eligibility restrictions, the client's VI assessment score dictates whether a client can proceed with a PSH or a RRH match. With this method in place, there are several hundred individuals that are not accounted for on the Permanent Supportive Housing/Chronic By-Name List, nor the Rapid Re-Housing By-Name List.

To rectify this process, eliminate unnecessary barriers, and "right-size" the CES portfolio of persons pending housing, the CES Task Group approved unanimously to remove the VI as the determining factor of which housing opportunity a client is eligible for, relying solely then on the HUD requirements.

#### • Elizabeth Hall, Burnstein Family Foundation

Prior to QuikTrip, Lauren was a Production Manager for Winnercomm, a television sports production company that at one point produced 85% of ESPN programming. Lauren is a native Tulsan and graduate of the University of Oklahoma and Bishop Kelley High School. She currently serves on the board for the Foundation for Tulsa Schools, is Chair of Resource Development on the board for Family and Children's Services and is the Chair for Strategic Initiatives on the board for National Safe Place. Lauren resides in Tulsa with her husband and three children.

#### • Kim Koch, Saied Music

Kim Koch represents the third generation as Vice President at Saied Music Company, founded by her grandfather Jimmie Saied and now celebrating their 77th year under the leadership of her father, Bob Saied. Saied Music is a full-line music retail store with six locations, headquartered in Tulsa, OK. A University of Tulsa grad holding a Bachelor of Music in vocal performance, Kim pursued graduate studies in opera at Manhattan School of Music. After teaching for five years in Tulsa Public Schools, and staying home while her children were young, Kim returned to the family business in 2011. #### • Sarah Grounds, City Lights Foundation

Sarah is a founding member of The City Lights Foundation of Oklahoma. With her husband, and a small group of friends, Night Light Tulsa was started in 2013. That outreach led to the forming of City Lights as a non-profit in 2015. Some of her most proud work includes efforts during the pandemic leading and operating the City Lights Hotel.

Sarah is responsible for ensuring the mission, vision, strategies, core values, and goals of City Lights are carried out. She believes deeply in these things and strives daily to carry out a lifestyle of service and community. She is grateful to be trusted with others' stories and to walk with them through difficult times. She believes each of us are equipped to make our community a better place for all people.

#### • Beth Svetlic, Youth Services of Tulsa

Beth Edwards Svetlic is a licensed clinical social worker who has been practicing since 2002. Since receiving her masters in social work from the University of Oklahoma she has worked with children, youth, families and adults in the areas of school social work, mental health, housing and homeless services in both urban and rural settings. In her current role with Youth Services of Tulsa she oversees programs that provide a wide range of services to youth ages 12-24 and their families. Serving over 5,000 youth a year, YST provides services in the areas of delinquency prevention, positive youth development, counseling and substance abuse services and runaway and homeless youth services. Beth currently lives in Tulsa with her husband and three kids and while she is sure she has hobbies she would enjoy, most of her time is spent driving kids around to various activities.

#### • Captain Dan Nelson, Salvation Army

Captain Dan Nelson currently serves as Area Commander for The Salvation Army of Tulsa which gives oversight to the organization's work in Tulsa, Rogers, Wagoner, Creek and Okmulgee counties. He does this work alongside his wife, Major Sarah Nelson. Their previous appointments together were in Knoxville, TN, Atlanta, GA and Danville, KY. Born and raised in Rockford, IL, Dan was ordained and commissioned a Salvation Army officer in 2008. #### • Tim Newton, Tulsa Dream Center

Tim is the Tulsa Dream Center's third executive director since its inception more than 20 years ago. He started in 2010 as Programs Director following five years in international missions and five years in civil engineering. He has a Master's Degree in Divinity from Oral Roberts University and a Bachelor's Degree in Engineering from Georgia Tech. Tim oversees an organization that touches more than 5,000 lives each year, a \$2 million+ annual operating budget, and serves as the organization's lead minister and spokesman. Tim has a huge heart for at-risk youth, community development and entrepreneurship.

#### • Stephanie Younis, Tulsa County Alternative Courts

As Director of the Alternative Courts Team in the Tulsa County District Attorney's office, Stephanie Younis is a prosecutor focused on alternatives to incarceration for crimes stemming from mental illness and substance use disorder. Her team handles Drug Court, Criminal Mental Health Court, Veterans Court, Mental Health Diversion, and Misdemeanor Diversion cases. She is the lead prosecutor charged with implementing the Tulsa County Justice Reinvestment Act award (\$1 million, 2020) and the Comprehensive Opioid, Stimulant, and Substance Abuse Sitebased Program award (\$1.2 million, 2021). Before joining the District Attorney's Office, Stephanie represented children and indigent parents with cases in the child welfare system in Wagoner County, Oklahoma. Stephanie also worked as a Policy Analyst for the City of San Jose, California, focused on public safety, transportation, and the environment for five years. She holds a J.D. from the University of California College of the Law, San Francisco and a B.A. in Criminology, Law and Society from U.C. Irvine. Stephanie has been a member of the Oklahoma Bar Association since 2013. She is married to Rami Younis, a Professor at the University of Tulsa and they have two children.
