Questions that measure performance and this year they have created an even stronger emphasis on partnering with public housing authorities and and so any applicants that are able to submit an application in partnership with a public Housing Authority, whether it's as a subrecipient or a contractor, or they're using matching dollars to do that, our COC would, it would increase the number of points we received from her.

They have also emphasized partnering with health care providers and that being a formal partnership, whether it's a part of your application as a sub recipient or a contractor, that at minimum having an MOU and we made some updates and around the addressing racial equity in the application, you'll see that in our resilience and equity checklist tool, which is aligned with the HUD priority.

Similar to last year, we've also included questions around involving persons with lived experience in decision making positions and through the project application. And this year, which is new and very exciting, HUD has updated the definition of homelessness and to include additional language specifically stating that people who are fleeing domestic violence they they're now considering that other dangerous, traumatic or life threatening conditions related to violence against the individual or



family member, which really broadened that definition to increase safety for all people and and they have also added a new process where renewals can do, can amend their project budgets to include and funding for to facilitate VAWA emergency transfers.

And so this is new.

Normally you can't do an amendment in Esnaps, but renewals can. You can either do an expansion to add this budget line item to your project, or you can do a budget amendment and shifting less than 10% and and we are recommending that projects consider adding at least some funding under this budget line item in order to easily utilize it.

So for the options for creating new project and new projects under the COC bonus and so we have CC bonus, the DV bonus expansion and transition grants really quickly, I'm gonna come back up here.

So when we talk about the COC bonus, the amount on this chart and the 305,000 that is the amount that our COC can apply for with CEOC bonuses.

So if we receive a lot of CEOC bonus applications, we will rank them based on how much we have within that funding amount and include it in tier one and Tier 2. Anything that exceeds it will not be included and and then for the DV bonus we get 10% of our PC PPRN, which is the 415,000.

OK, So what applying for those funds under the COC bonus? You have the following project types that can be and submitted and so that's permanent supportive housing, rapid rehousing, the joint transitional to rapid component HMIS and coordinated entry for permanent supportive housing. Many of you are probably familiar with it, but we'll just really quickly. So that includes having a rent subsidy where the tenant pays no more than 30% of their income, and then it also includes case management services and the case management does not should not be required, but it should always be available for the tenants, umm, for rapid rehousing that includes rental assistance, housing, search and placement and also case management, rapid rehousing programs at the case management is expected to occur and at least once a month and then also to use progressive engagement for tenants to take over their rent portion at least within two years, they're joint transitional to rapid is accommodation of transitional housing and rapid rehousing.

And so you have to when applying for this project, have at least twice as much of the transitional housing units in order to ensure that people are accessing permanent housing.

And then HMIS we housing solutions as the HMIS lead agency and so on a like we're the ones who apply for those funding and coordinated entry really quickly.

If people have questions throughout this, please feel free to add them in the chat at any point in time.

If we don't get to them today, then we will post them on our website along with the PowerPoint slides and the recording.

Umm so then for the domestic violence and the DV bonus projects, the eligible project types are rapid rehousing and the joint transitional housing, the bulleted items show like how they're being measured and approved by HUD must follow housing first principles and and they need to demonstrate a need in the community for that project type with that subpopulation and they will be measured on how they utilize victim centered practices and then also including survivors of lived experience for the supportive services only coordinated entry.

It's really focused on implementing policy and procedures and practices and for people who are fleeing and dangerous situations for the DV bonus, you can only submit one new DV bonus project for SSO CE.

Our community has not submitted one and so that is one of those project types that's available.

You can apply for as many projects through rapid rehousing and the joint transitional housing, and to wrap it, each project must be at least \$25,000.

So and and then for, they're not allowed to be combined with reallocated or CC bonus funds.

So if you're doing the DV bonus, you're just doing the DV bonus and then the DV bonus projects are, and if they're not selected for the DB specific funding, they'll be considered and moved over to the General C bonus funding.

Uh for renewal projects mentioned earlier, we talked about an expansion and including considering applying for an expansion to include the vowel budget line item, and so you could use.

The expansion process for that and you would be submitting a renewal project application and a new project application and so for the local competition, you'll be doing both as well.

And then in Esnaps you would be doing both as well.

The grant term is of one year for an expansion and that's yeah.

So for transition projects, we actually did not receive any notification from anyone who is interested in a transition project.

So I won't go too much into this if someone changes their mind and is interested, please contact us at housing solutions and at your earliest convenience.

It's only applies to renewal projects.

Umm so for this is so important information for renewal projects and so for the DV bonus apps may include the request to add eligible activities or shift up to 10% and then for renewal projects they may include a request to add eligible activities to shift up to 10%.

You can also change your subpopulation and.

And UM, please be mindful of when you're requesting a shift.

If you decide to do so, if you request a shift of more than 10%, HUD will correct the project budget and do the previously awarded amount.

And consolidation.

So there are few renewal projects that may be eligible for consolidation and I encourage any of y'all to to take that into consideration.

If you are eligible and it's, it would make life easier.

And that you would have fewer projects each year to submit applications for,

including submitting a PR's and doing all of the issues and conditions.

And so if you need assistance, we're more than happy to help with that.

I also included the NOFO pages that talk a little bit about the consolidation project.

In order to do so, though, be mindful that the current period of performance and budget period and dates must be must end in 2024 and that the projects are in good

standing.

Umm, this is just to highlight our renewal projects and and to see what is funded currently under the COC program.

We have one transitional housing, 1 transitional to rapid 4, rapid 6 PSH and 1C E and one each.

My and through these funds, we serve roughly around 408 units or beds a year. So if you yeah.

So on the Tulsa on the Housing Solutions website, you'll see a way home for Tulsa tab at the top and you'll click on the NOFO and that page will include all of the important information you'll need for this year's funding competition, including our policies are NOFO standard of operations.

I really encourage you.

All to read these and this outlines the process for rating and ranking, how that looks at the local level.

Umm it.

Thank you, Karen.

Karen included the link in the chat.

It also includes what you need to know for submission requirements.

So for example, if you are a new project applying you are required to get all of your application materials and on time you will not be considered for the funding. If for any late applications it also talks about the appeals process and the notification of ranking.

On this site there it includes the important dates, but I also just wanted to review them with you all here and these are the but the local application deadline is due on the 25th and then we are asking that renewal projects submit the PDF of their E snaps applications just for review by the 31st and then we'll have opportunity to make updates as long as we have all of the E snaps information in E and by the 20th of September.

So and please mark your calendar for these dates so that you're aware of them, especially if it's and then intent to appeal and the appeal date and read through the

standard operating procedures for what that process looks like.

Once again, you'll see when you go to the NOFO page, the competition overview and then application materials and additional resources and documents.

And then the key dates is where that timeline is and important dates.

And if we have to make a change to anything, we will use red font on the website and we will send out an email notification to let you know that something has changed.

It could be that we pushed a date or that we notice something in an application material or we just have updated information.

And renewal project, application materials and so first while you are doing your application to look through before and throughout your application, the scoring tool, that is how the review team will award points to your project and those points will be used to rank your project competitively.

So it's important to know what are they looking for?

What is the point structure?

Am I meeting all of the required standards for this question and throughout the entire application and this year we made a few updates to the application.

So the RFI application for renewal projects and please carefully review the checklist and I can pull that up if that would be helpful.

But and it has a checklist section and to make sure that you're looking through that very carefully and add those as attachments in your application and the also the Novo resilience and equity checklist has been updated, it has more, both the close ended piece but also a lot of open ended prompts to requesting for narrative sections and also to be mindful of this scoring tool because it's asking for more data this year.

And so to like carefully read through that and the instructions and the checklist document and presto, I'm still learning Presto, but so I don't know if I could answer any of your questions.

And Karen is on this call and today and is the Presto expert and so please feel free to type any questions in there if you have them. Yeah.

Or like you can ask questions to like we wanna make sure that and you know, we're getting that piece done as soon as possible and then also in the actual application at the very end there's a question that asks for you all to provide a response to your data that was submitted in Presto.

It's if you have any comments the detailed as much as possible, the review team will be looking at that item in the application and will be using that to make any adjustments to your scores if needed.

So we believe it's the very last question.

Any questions for Karen?

And we can wait until after as well.

OK, feel free to put any questions in the chat and whether it's pressed or related or not.

UM, OK, so a reminder for everyone who is eligible to apply.

So those are listed there and they and every applicant must have an active Sam's account.

And then the UEI you also must have an updated code of conduct on file with HUD. While we were doing the YHDP, the homelessness demonstration projects, we realized that that was a little bit confusing for people and especially newer applicants.

And so to make sure that you have that there's a link in this PowerPoint slide where you can check huds website to make sure that you have one on file.

If you don't, there's also instructions on that from that link that shows you how to complete that.

More information is in the NOFO, and I've outlined those page numbers.

I also want so HUD is really emphasizing increasing, you know partnerships and to remind everyone that if you have a subrecipient the same requirements for eligible organizations, umm are like apply.

Umm, so on the website there are links to the new project application materials and once again the scoring tool is an important document that you will want to review very closely.

It's how it outlines how many points you will receive for your response and for each item, and then.

So for new projects you have several different documents that you may have to submit.

If you don't have them, so for example the RFI application is required for all of the applicants, the service standard self assessment.

If you have not submitted that in the past, then you will need to submit that and then all new project applicants will have to submit as an attachment.

The project budget template.

There's instructions that go along with it and then also the CC NOFO resilience and equity checklist.

Really quickly, let me pull up.

OK.

Yes, I'm gonna do an exam.

I'm gonna show an example.

Of what?

The scoring tool looks like.

OK, so this is the renewal scoring tool, so there's a new project and a renewal and it outlines and the total point structure and threshold requirements which for renewals and you have most likely already that those and still do and for the so it'll tell you exactly like what points you receive and these are the ones that are scored in Presto. And so based on the information that Karen sent back to you all on your Presto numbers, if there's something that isn't resolved then to make sure that you're putting that information in that last question in the application materials.

So this year we have outlined like the point structure, so you can quickly see it through the renewal application and the total points is 106 and then this is and to show had that we met requirements that they want us to meet.

Umm, when you on one of the links and this page is really helpful it and we'll take you over to like esnaps or frequently asked questions.

So you can always ask a question to HUD by clicking on this and then also you can access esnaps navigation and application material resources.

This year, we're not requiring applicants to submit their E snaps application in advance.

We're waiting until later, and because we're under such a tight timeline and then and to review others, you can go to thegrants.gov page to see more information about the NOFO.

And so you can actually click on here to access the NOFO and read through it, which I recommend.

Umm.

And then alright, see the budget template I already have it open.

OK, so this is the budget template for new projects and what you will do is you will enter in whatever amounts you're requesting for and then here you wanna be very specific.

So bus fare is probably not specific enough, and you're a narrative, so you would

want to say something like bus fare at 125 per person times 120 people equals this much amount and you'll wanna do that for each item.

To be specific, her new projects, who were also submitting this budget, you will need to look at the FMR and add it on here for one bedroom, 2 bedroom, 3 bedroom. We actually have that link in the budget instructions to make it easy to access, and so it'll come out, and this will match what you're entering into esnaps and as well. And then we added this budget and the vowel budget line item broken out into the new eligible costs.

So if you're including that as a new project, you would enter that information in here and then instead of having it on on this because I would have had to redo all of the formulas.

Umm, we're asking that you put that total right here and it should match this tab right here.

So that will be Li, you would just put the total amount that you're requesting. Once you fill out this detailed on here and just as a quick FYI if anybody wants to use this, you can always add this like add in 12 months here and then use this as the as a template for your budget to actuals to track on a monthly basis.

Let's see and then.

Over here.

OK.

So you'll see all of the required documents, so the self standard is for new projects who haven't submitted that document before budget instructions, and then all applicants are submitting this NOFO resilience and equity checklist as well. If we can pull that up really quick.

The instructions have changed and and to also look at the project scoring tool and then if you were submitting this for multiple projects and for example renewal and there's several agencies that have several projects just to list them in the project type here.

So we know which ones that you're referring to that are COC funded and then you'll check yes, no.

Unsure and then you'll put in narrative here and a narrative here as well. So that's a little bit different from last year, UM and and. Yeah.

So these are check all that apply over here and then make sure to put your narrative and then these are all links and resources to help kind of guide your response. We're asking that agencies include more information about how they measure performance and what that looks like for them and how they use that to understand where they are and where they need to go to create a more equitable and just homelessness response system and program design.


Medical providers can also apply for funding as long as they meet all of the eligibility requirements of an organization.

Umm, so the first question is like preparing for the next year because we do know that this is a tight timeline.

I definitely think that's something that we are very interested in doing is more in advanced capacity building for new agencies who are wanting to join in. And so we can definitely do more workshops around that as well.

And not only for just C projects, but for other, you know, projects that are commonly funded and through, you know that funds homelessness services that are dedicated. And so even considering like ESG or because we follow a lot of the same requirements and then going to the reporting piece, so each project has to submit an A report to HUD called the annual Performance Report and every agency has to enter data following HUD HMIS data standards into the local HMIS database or comparable database for victim service providers.

And so we use service point by well, sky and so it makes it easy to pull that report and then you submit it in to a system called Sage uh.

When it comes to the beds or units, whatever you put in your application is what will also be entered into sage.

And so it'll calculate a report called the Bed unit utilization rate.

And so we can see our all beds being filled is there to what extent are they over serving a lot of projects tend to over serve as well and and so uh, really following those HUD HMIS data standards is an is an important part of this and also there's a lot of compliance pieces but it's all on the HUD exchange and I feel like once you learn it, I mean they've really change it and there might be like a few changes so. Yeah.
